RESULTS OF THE FEBRUARY 2026 ARIZONA UNIFORM BAR EXAMINATION

The February 2026 Arizona Uniform Bar Examination (UBE) was administered on February 24 and 25, 2026. There were 228 applicants, of whom 121 met the score requirement for admission in Arizona. The overall pass rate was 53%.

The following individuals received the highest scores on the examination:

First Place: In compliance with Ariz. R. Sup. Ct. 37(c)(2), applicants who applied pursuant to Rule 34(b)(2) and who have not satisfied the evidence of graduation requirement are not listed. Upon submission, a revised list will be posted.
