Administrative Order No. 2024 - <u>78</u> (Replacing Administrative Order No. 2011-141 effective July 1, 2024

On December 22, 2011, the Court issued Administrative Order No. 2011-141 adopting fee changes, concurrent with the adoption of the Arizona Uniform Bar Examination, intended to ensure that the Court's admission functions remain self-supported. Arizona's fees have remained unchanged since that time. In the intervening 12 years, the consumer price index has risen approximately 37%, and the Court's costs to administer the attorney admissions program have increased approximately 39%. In 2027, the Court will administer a next-generation bar examination to evaluate applicants' minimum competency to practice law in Arizona. To ensure the Court's admission functions remains self-supported, it is necessary to modify the Court's admission fees and deadlines.

Therefore, pursuant to Rules 34 through 38, Rules of the Arizona Supreme Court, as amended, and Article 6, Section 3, Constitution of Arizona,

IT IS ORDERED adopting the Schedule of Fees and Filing Deadlines set forth in Attachment A effective July 1, 2024; adopting the Schedule of Fees and Filing Deadlines set forth in Attachment B effective January 1, 2027; adopting the Schedule of Fees and Filing Deadlines set forth in Attachment C effective July 1, 2029; and adopting the Schedule of Fees and Filing Deadlines set forth in Attachment D effective July 1, 2032-June 30, 2035.

IT IS FURTHER ORDERED that this Administrative Order replaces Administrative Order No. 2011-141 effective July 1, 2024.
